Mr. Hendrix stated, "Gentlemen I am presenting this report to comply with the ordinance implementing the 4% insurance premium tax (IPT) to pay the debt on the Convention Center. The ordinance states that the status of the 4% IPT be reviewed periodically, but no later than five years. We actually track the IPT monthly, but I am making this public report in compliance with the ordinance. For the period July 2009 thru April 30, 2014, the IPT revenue for the 4% piece was \$7.1 mil. The debt service paid for that period was \$6.8 mil, and we received an interest rebate from the IRS in the amount of \$1.2 mil. We receive the rebate due to a special provision available at that time by issuing Build America Bonds. That makes the IPT funds available at April 30<sup>th</sup> \$1.5 mil. Next, we subtract the first and second escrow payments of \$425,000 and \$393,414.41 respectively because they are needed to make the next bond payment, thus are not deemed as "excess of requirements". The remaining balance of \$735,141.78 reflects the "excess" on hand at April 30. From a finance view we are collecting funds more than adequate to pay the debt service, thus we are not having to dip into reserves to make the payments. To put the \$735,141.78 into perspective, the annual debt service is \$1,666,324 so we have a little less than a half years debt service in reserve."
