Recommendation: Bobcat of Evansville

Daviss County Fiscal Court received eleven (11) bids. Bobcat of Evansville is the lowest and best evaluated bid, having only a minor exception to the bid documentation. It is our recommendation to award Bid No. 15-2018 to Bobcat of Evansville for the 2018 Bobcat T770 in the amount of \$62,210.88.
